

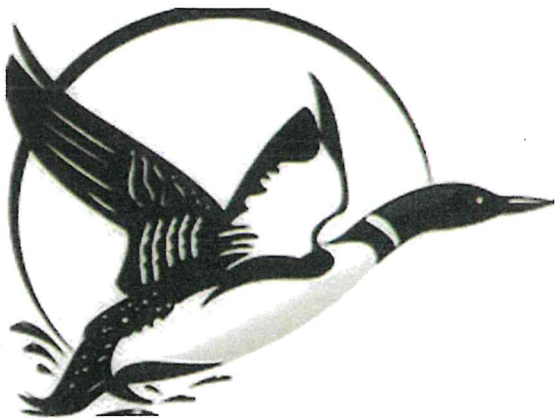

### TRANSFER STATION, TOWN BEACH, DOUGLAS MOUNTAIN

### PASS INFORMATION

The passes are good for the **Transfer Station** (at 141 Long Hill Rd.), the **Town Beach** (at the end of Marina Rd. – off Shore Rd. across from Sebago's Station 4 and for parking at the **Douglas Mountain** hiking trails (on Douglas Mountain Rd. – off Dyke Mountain Rd.). **Donations which help to maintain the hiking trails are always accepted and appreciated.**

The “sticker” type pass is to be placed on the front windshield, lower left hand corner (driver's side).

If you have friends or renters that come to stay for a week or two, they would need to obtain the “hanging tag” type of pass to access the aforementioned locations. This hangs from the rearview mirror of their vehicle.

The applicable fees for this type of pass are \$5.00 a week or \$20.00 a month. The following information is needed to obtain a “hanging tag” type of pass:

1. Valid Dates of Permit
2. Issued To (Name)
3. License Plate Number
4. State (the license plate is from)

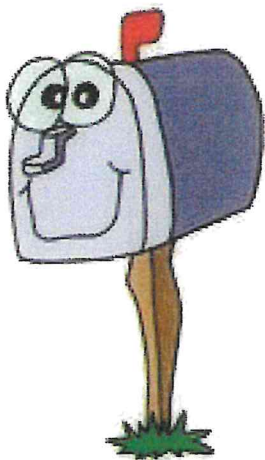
## Ask the Public Works Director

How do you handle mailbox damage done by your truck or plowed snow/ice from your truck? Any difference if the mailbox is within your right-of-way or outside the right-of-way boundary?

What if someone is going to “fix you” by erecting an immovable “deadly fixed mailbox” made of concrete, steel, brick etc.?



Mailboxes are in the right-of-way by permission of the municipality and if damaged, there is no legal entitlement to replacement or payment.



If the mailbox is within the right-of-way, the municipality has a legitimate concern for the safety of drivers and for its own potential liability under the Highway Defect Act, since a mailbox that is a “deadly fixed object” may be a highway defect. If outside the right-of-way, however, the mailbox is on private property and is beyond the municipality’s jurisdiction.

No municipality should tolerate the presence of “deadly fixed object” mailbox posts (such as concrete, granite or steel I-beam posts) in the right-of-way since this could constitute a “highway defect”. The municipality should request immediate removal of the post by the landowner (who also could be held liable for property damage or personal injury). However, if the landowner does not cooperate, it is better to obtain a court order for removal instead of the municipality exercising “self-help” and removing the post itself.

# Excise Tax

**Excise tax** is an annual tax that must be paid prior to registering your vehicle. Except for a few statutory exemptions, all vehicles registered in the State of Maine are subject to the excise tax. Excise tax is defined by Maine law as a tax levied annually for the privilege of operating a motor vehicle or camper trailer on the public ways.

## WHERE DO I PAY THE EXCISE TAX?

Excise tax is paid at the local town office where the owner of the vehicle resides. When a vehicle needs to be registered, an excise tax is collected prior to the registration.

## HOW MUCH IS THE EXCISE TAX?

The amount of tax is determined by two things:

The age of the vehicle

Manufacturer's suggested retail price ("MSRP")



**HOW IS THE EXCISE TAX CALCULATED?** Excise tax is calculated by multiplying the MSRP by the mil rate as shown below. The rates drop back on January 1st of each year.

YEAR 1 - .0240 mil rate

YEAR 2 - .0175 mil rate

YEAR 3 - .0135 mil rate

YEAR 4 - .0100 mil rate

YEAR 5 - .0065 mil rate

YEAR 6 - .0040 mil rate

*For example, the owner of a three year old motor vehicle with an MSRP of \$19,500 would pay \$263.25.*

## WHERE DOES THE EXCISE TAX GO?

The town that collects the excise tax can use it as revenue towards the annual town budget. Typically, the revenue is spent on local road maintenance, construction and repair.

## WHY IS THE TAX BASED ON MSRP?

Excise tax was designed with equity in mind. In 1925, this tax was enacted as a Maine law. At that time, the Legislature decided that the fairest tax assessment would be based on what the manufacturer suggests it sell for. This law has remained in effect for more than 85 years to ensure that everyone who drives the same vehicle pays the same amount of tax.



## WHERE CAN A TOWN GET THE MSRP?

There are several resources for the MSRP that will provide the information on the retail price of a vehicle. New vehicles are required to have a window sticker and the window sticker must be must be presented on first time registrations.

For used cars, individuals and municipalities can use the *NADA Guide*, the *New Car Cost Guide*, the *Automobile Red Book* and the *Automobile Blue Book* to determine the MSRP of a vehicle.

Many towns have adopted software based on the *Automobile Red Book* and can use the VIN number to determine the MSRP of that vehicle.

**PLEASE NOTE: The State of Maine Property Tax Division only provides quotes to the Municipal Tax Collector, not to individuals.**



# Property Tax Exemptions

## Homestead Property Tax Exemptions

If your home in Sebago is your primary residence you may be eligible for a Homestead Exemption. Your primary residence is determined by the information on your drivers license. You will need to have owned the property for a full calendar year as of April 1. Also the exemption form needs to be received by the Sebago Town Office before April 1st of any given year.

## Veteran Property Tax Exemptions

Like a Homestead Exemption application a Veteran Exemption application must be received by the Sebago Town Office before April

1st of any given year. As long as you are veteran and your primary residence is in Sebago you can apply for this exemption.



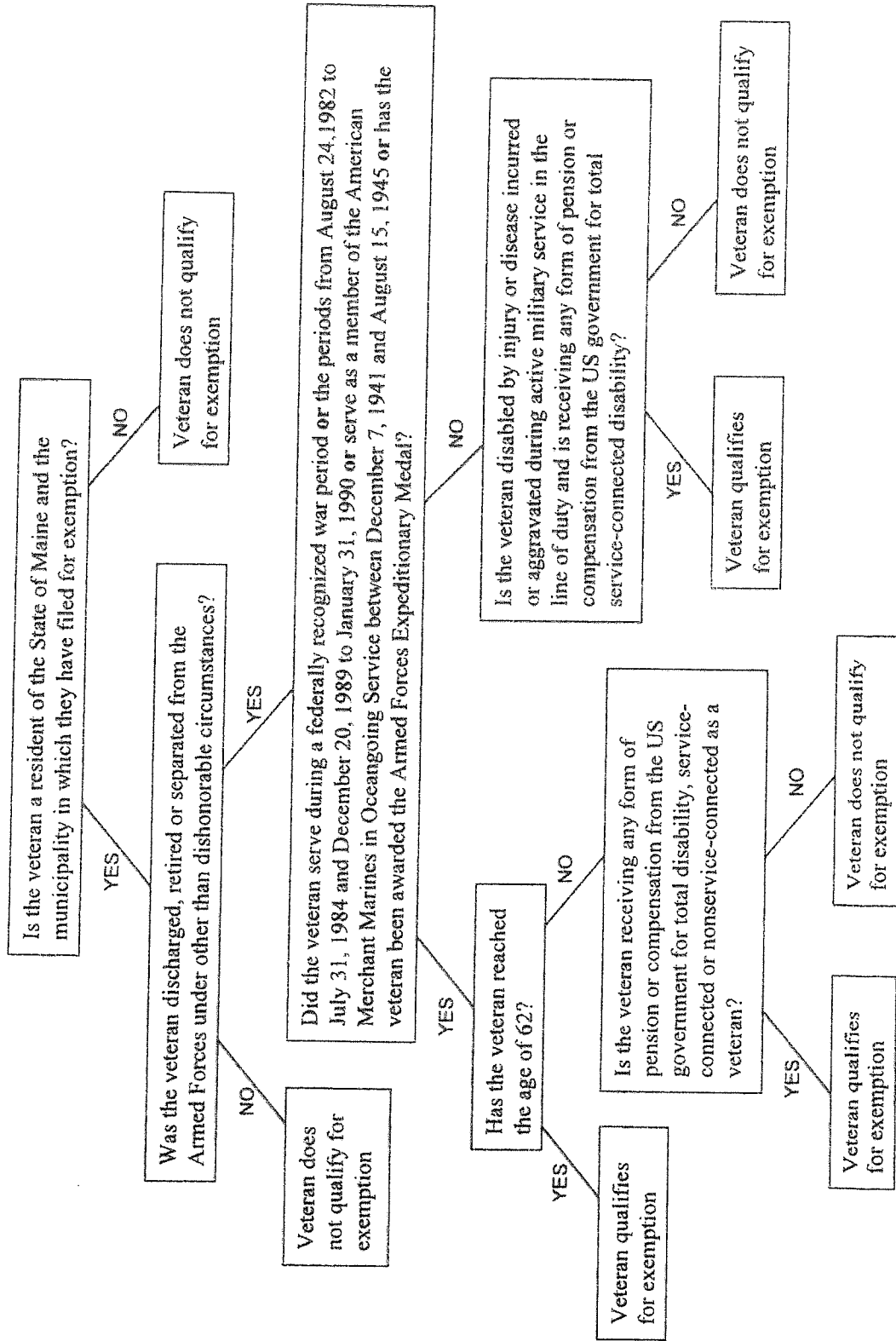

## Town Office



The Town of Sebago Municipal Offices are located at 406 Bridgton Rd. The Town Manager, Town Clerk, Code Enforcement Officer and other elected officials offices are located there. The Town Office is open Tuesdays 10:00 AM—7:00 PM and Wednesday, Thursday and Friday 8:00 AM—5:00 PM. The office closes every day from 12:00 to 12:30 PM for lunch. First time "new to you" vehicles (never register in you name) whether it be a car, boat, ATV or snowmobile, **will not** be processed a 1/2 hour prior to closing. In addition, the person or persons to whom the vehicle is being registered must come in and do the registration themselves. Please plan transactions accordingly. We apologize for any inconvenience.

## Property Taxes



Property taxes are assessed by State Law on April 1st of each year. Whoever owns the property as of that date is responsible for the taxes on that property for the coming fiscal year (July 1st of the current year to June 30th of the following year). Annual tax bill amounts are payable in two equal amounts with the first installment due on the first Tuesday in November, and the second installment due on the first Tuesday in the following May.

## Annual Rabies Clinic

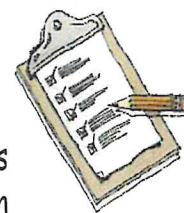
The annual rabies clinic is held at the "Old" Town Hall Building. The clinic is limited to cats and dogs only; no puppies or kittens please. Cats must be in carriers, and dogs must be on a non-retractable leash. The cost per animal is \$10.00. Please bring the most recent rabies certificate to receive a 3 year shot, otherwise a 1 year shot will be administered. ### Assessor's Field Work

John E. O'Donnell and Associates, Inc. is a municipal consulting firm specializing in tax assessing, tax equalization, and tax mapping. Every spring the Town of Sebago starts conducting its yearly assessing of residents properties. Employees from John E O'Donnell and Associates have permission from the Town of Sebago to assess all properties in the town. If you have any questions or concerns, please call 787-2457.



### Burn Permits



Burn Permits are required by Law when you want to do any open burning at any time during the year. To obtain a permit you can go to the <https://www.wardensreport.com/#!/townSelect/3>. You can also get a "Seasonal Campfire" permit at the Town Office if you plan to have a campfire or fire pit to roast marshmallows.

### Town Hall Use

The Town Hall/Recreation Center is available for Sebago Residents to rent for events such as, a birthday party, wedding, shower or fundraising event. The rental fee for residents is \$150.00 per day, plus a \$150.00 deposit which is required to ensure the cleanliness of the building after the event. The fee is \$300.00 per day, plus a \$300.00 deposit. You may contact the Recreation Director prior to renting the hall for a walk through.



### Sand & Salt

Sebago Residents and taxpayers may obtain sand and salt from the designated area in the lean-to building located in front of the Public Works Garage (next to the EMS Building). The sand and salt is for personal use **ONLY**, and **ONLY** for property located in the Town of Sebago.

### Hunting & Fishing Licenses

The Town Office issues Hunting and Fishing Licenses. If you would like a hunting or fishing license, please bring your driver's license or state identification card with you when applying for a license.

A firearms hunter safety course card must be presented when obtaining an adult firearms license for the first time. Age 16 and older, if the hunter has not held an adult license since January 1, 1976 a firearm hunter safety course is required before a license can be issued. An archery safety course card must be presented when obtaining an adult archery license for the first time. If the hunter has not held an adult license since January 1, 1980 an archery safety course is required before a license can be issued.



## Licenses for ATVs, Boats and Snowmobiles

The Town of Sebago can process first-time and renewal registrations for ATVs boats, and snowmobiles for residents and non-residents.

To process a **first-time registration**, that you have acquired **through a dealer sale**, for any of the above recreational vehicles, you will need the following:

- Bill of sale—that shows that sales tax has been collected from the dealer. *Please note: If your recreational vehicle is a used model and previously registered in Maine we will need the Maine registration number (ME number).*



To process a **first-time registration**, that you have purchased **through a casual sale**, for any of the above recreational vehicles you will need the following:

- Bill of Sale—which should include seller's name, buyer's name, VIN/ Serial number, Maine registration number (if previously registered in Maine), and the price of the recreational vehicle.
- Sales Tax—is required for first-time registrations. Be prepared to pay 5.5% of the sales price on a new recreational vehicle. *Please note: If your recreational vehicle is a used model and previously registered in Maine we will need the Maine registration number (ME number).*



To process a **renewal registration** for any of the above recreational vehicle please present your previous registration at renewal time.

## Registration Period

- All Boats expire December 31st of each year.
- ATV's and Snowmobiles expire June 30th of each year.

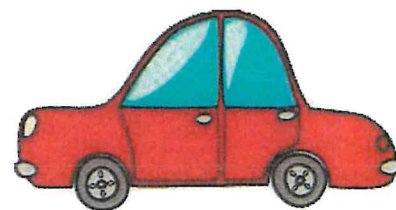
## So you just moved to Town, now what?



Notify the Post office of your change of address.

Within 30 days of moving to Maine, you are required, by law, to register your vehicle in this state. To complete the registration you will need to bring the following items to the Town Office:

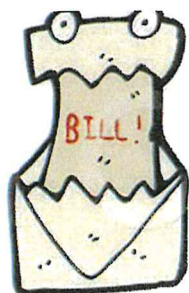
- The previous registration.
- The title or lien information, if the vehicle is a 1995 or newer.
- A bill of sale if the vehicle is new to you.
- A valid insurance card.
- Proof of current Sebago address, if you have not changed your drivers license yet.



After your vehicle is registered it needs to be inspected at an inspection station.

Obtain a Maine drivers license. You will need to visit a Bureau of Motor Vehicle Branch Office. The nearest BMV Branch is at 200 Expedition Drive, Scarborough, ME 04074 (near Cabela's). Their telephone number is (207) -883-2596 and their hours are Monday—Friday 8:00 am—4:00 pm.

Register to Vote. Please bring with you proof of identity and residency. This could be a Maine Driver's license with your Sebago address listed, or a piece of mail with your Sebago address, post office boxes are not acceptable. You can register to vote at the polls on election day, as long as you have the correct proof of identity and residency.

## General Assistance

General Assistance is a program that provides assistance for basic needs for eligible applicants who can not provide for themselves or their families. General Assistance provides a "specific amount and type of aid for a defined need during a limited period of time and is not intended to be a continuing 'grant-in-aid' or 'categorical' welfare program". (§4301(5))

Whoever knowingly and willfully makes any false representation of a material fact to the overseer of any municipality or to the department or its agents for the purpose of causing that or any other person to be granted assistance by the municipality or by the State is ineligible for assistance for a period of 120 days and is guilty of a class E crime. (§4315)

Pursuant to Title 22 MRSA § (4305) the municipal officers have adopted an ordinance which is available for public inspection. Also available for inspection is a copy of the State's General Assistance statutes.

Residents of the Town of Sebago who are having difficulty meeting basic needs such as housing, utilities (electricity and heating fuel), and food may apply for assistance at the Town Office during the following hours:

Tuesdays 1:30 pm — 3:30 pm

If an emergency occurs outside of these hours, applicants may contact 211 or visit 211.org.

The General Assistance Administrator must issue a written decision regarding eligibility to applicants within 24 hours of receiving an application.

The Department of Human Services toll-free telephone number to call with questions regarding General Assistance is 1-800-442-6003.

This program is funded by local property taxes with a 70% reimbursement from the State.

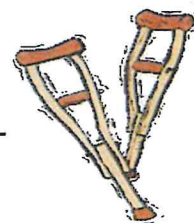

## **Boston Post Cane History**

In 1909 the Boston Post newspaper distributed specially designed walking canes to 700 New England towns. The canes are made of ebony imported from Africa and crowned with 14 karat gold. The canes were presented to the oldest living male of those communities. Women were added to the list of cane recipients starting in 1930. The original cane that was given to the Town of Sebago is now on display at the Town Office. A replica of the cane is now given to the town's oldest living resident.

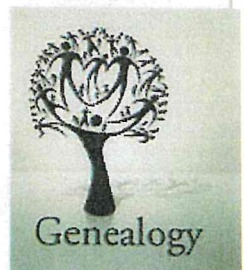

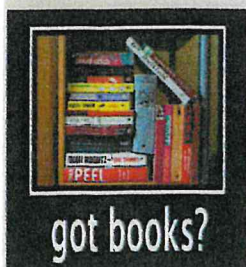

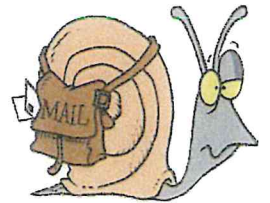
### Lion's Club
