Dear Citizens of Sebago:

For the past seven years as your Governor, my priority has been to make Maine—our people—prosper. Helping you keep more money in your wallet by reducing taxes has been part of that mission.

Too many Maine families are facing skyrocketing property taxes that strain household budgets. Our elderly on fixed incomes are particularly vulnerable to these increases. School budgets are often blamed for annual increases in property taxes. But there's another reason. A tremendous amount of land and property value has been taken off the tax rolls, leaving homeowners to pick up the tab.

As of 2016, towns and cities owned land and buildings valued at nearly \$5.5 billion statewide. Large and wealthy non-profits, such as hospitals and colleges, often escape paying property taxes on their vast real estate holdings—totaling more than \$5.1 billion statewide.

In Maine, nearly 2.5 million acres of land have been set aside for conservation by the federal and state governments and non-profit organizations, including land trusts. Municipalities are losing out on property taxes on an estimated \$2 billion in land that has been either removed from the tax rolls or prohibited from development—shifting the cost of municipal services to local homeowners through higher property taxes.

It's time to recognize the results of taking property off the tax rolls and identify solutions to reduce the burden on our homeowners. My administration's proposals have been met with staunch resistance.

In 1993, about 35,800 acres of land were documented as land-trust owned. That number has increased by an astonishing 1,270 percent. Land trusts now control over 490,000 acres with an estimated value of \$403 million. We must restore the balance. We will be working this session to ensure all land owners are contributing to the local tax base. It's time for them to pay their fair share.

I encourage you to ask your local officials how much land in your municipality has been taken off the tax rolls, as well as how much in tax revenue that land would have been contributing today to offset your property taxes.

Dear Friend,

I hope this letter finds you well. It's a privilege to share an update on my work to represent you and your family in Washington and in Maine.

Even though Washington is so bitterly divided these days, I've continued to look for bipartisan opportunities to address issues important to our state. Nearly all the bills I've introduced this Congress have Republican cosponsors.

One piece of legislation would help protect our state's economy by investing in working waterfronts. Another would allow Mainers to import less expensive prescriptions from Canada. And several bills would help our farmers capitalize on the fastest growing areas of agriculture—local and organic sales—by investing in research, increasing consumer access to healthy food, and improving farmer programs.

I'm happy to report bipartisan victories for our veterans as well. After working for years with Maine's Congressional Delegation, we were finally able to push a much-needed expansion of the Portland VA Community Based Outpatient Clinic through Congress. Legislation I introduced to help veterans who find themselves in debt to the Department of Veterans Affairs unanimously passed the House of Representatives. And full GI Bill benefits were extended to a group of veterans who had been denied them previously—an issue I've introduced legislation to address.

While I strive to find common ground with my colleagues on everything from rural broadband access to economic development, there are many areas where I will not compromise. I have serious concerns about the direction the Trump Administration and its allies in Congress are taking our country. In so many ways, they have abandoned America's leadership in the world, made our country less safe, and are jeopardizing our future. They've weakened our health care system, rigged the tax code against working families, and endangered the environment. With one hand, they are taking away resources our families and communities need. With the other, they are offering generous giveaways to giant corporations and the wealthiest Americans.

Over the last year, I've received an unprecedented amount of feedback on these issues from my constituents. With their concerns and interests in mind, I have fought hard against these policies. I will continue using my role in Congress and the Appropriations Committee to hold the Administration and the President accountable.

Please keep in touch with your views or if there is anything I might be able to help you with. My office assists hundreds of constituents every year who have issues with federal programs or agencies. It's an honor to serve you.

Dear Friends:

It is an honor to represent Maine in the United States Senate. I am grateful for the trust the people of our State have placed in me and welcome this opportunity to share some key accomplishments from this past year.

Maine has the oldest average age in the nation. As Chairman of the Senate Aging Committee, my top three priorities for the Committee are fighting fraud and financial abuse directed at our nation's seniors, increasing investments in biomedical research, and improving retirement security. Following the Committee's investigation into skyrocketing prescription drug costs, I authored bipartisan legislation to foster generic competition, which was signed into law. The Aging Committee's toll-free hotline (1-855-303-9470) makes it easier for seniors to report suspected fraud and receive assistance. To support the 40 million family caregivers in the United States, I am proud to have authored the RAISE Family Caregivers Act to create a coordinated strategy to support family members who make countless personal and financial sacrifices to care for their loved ones.

The opioid crisis touches families and communities across our state. As a member of the Appropriations Committee, I fought for significant increases in funding to support community, law-enforcement, and public health efforts. In April, the State of Maine was awarded over \$2 million to fight this devastating public health crisis. Additionally, I have authored legislation to support grandparents and other extended family members who are raising grandchildren as a result of the nation's opioid epidemic.

Biomedical research has the potential to improve and save lives, and also supports good jobs at research facilities here in Maine. Last year, the Appropriations Committee approved a \$2 billion increase for the National Institutes of Health for the third consecutive year. This includes an increase of nearly 30 percent for research on Alzheimer's, our nation's most costly disease. As founder and co-chair of the Senate Diabetes Caucus, I work to raise awareness of the threats posed by diabetes, invest in research, and improve access to treatment options. My bill to establish a national commission of health care experts on diabetes care and prevention was signed into law in 2017.

We owe our veterans so much. Last year, I worked to secure the authorization of a Community-Based Outpatient Clinic in Portland to support the health care of Maine's veterans in the southern part of our state. I also worked to secure funding extensions to help veterans throughout rural Maine receive health care within their communities. I also worked to secure funding for housing vouchers for veterans to reduce veterans' homelessness.

Maine's contributions to our national security stretch from Kittery to Limestone. I successfully advocated for critical funding for projects at the Portsmouth Naval Shipyard for construction of an additional ship that will likely be built at Bath Iron Works. This funding will strengthen our national security and preserve great jobs in our state.

As chairman of the Transportation and Housing Appropriations Subcommittee, I worked to increase funding for the TIGER program that has provided Maine with more than \$122 million for vital transportation projects. For housing, I worked to provide \$160 million to help communities protect children from the harmful effects of lead poisoning.

Growing our economy remains a top priority. I supported the comprehensive tax reform bill because it will help lower- and middle-income families keep more of their hard-earned money; boost the economy; and encourage businesses, both small and large, to grow and create jobs here in Maine and around the country. This legislation contains key provisions I authored that are important to Mainers, including preserving the deduction

for state and local taxes, expanding the deduction for medical expenses, and enabling public employees such as firefighters, teachers, and police officers, as well as clergy and employees of nonprofits, to make “catch-up” contributions to their retirement accounts. I led the effort to ensure that the tax cut will not trigger automatic budget cuts to Medicare or any other programs.

A Maine value that always guides me is our unsurpassed work ethic. As of December 2017, I have cast more than 6,500 consecutive votes, continuing my record of never missing a roll-call vote since my Senate service began in 1997.

Dear Friends,

Representing Maine in the United States Senate is an honor.

I continue my work on the Senate Armed Services Committee, each year authorizing the funding required to build our military capabilities and ensuring that our service members are trained and equipped to defend our nation. I was pleased to be part of a bipartisan effort to enact a new law to simplify the appeals review process to reduce the backlog our veterans are facing, as well as a new law that provides critical funding to the VA Choice Program, allowing veterans in rural Maine to access services closer to home.

While my committee work is important, working to combat the opioid epidemic is one of my top priorities. Although Congress has made some important strides, much remains to be done to provide additional funding for prevention, treatment and enforcement. I am working with colleagues on both sides of the aisle to pressure the Drug Enforcement Administration to reduce the amount of opioids produced and to thwart the flow of fentanyl and other deadly drugs into our country.

I am very optimistic about the integrated, multiagency effort I led with Senator Collins to foster innovation and commercialization in Maine's forest economy. Through the Economic Development Assessment Team (EDAT) we are already experiencing increased federal investments that will strengthen our existing forest products industry and help support job creation in rural communities. Initiatives like Cross Laminated Timber, Combined Heat and Power, nanocellulose, 3D printing with biobased materials and other biobased products will mean that Maine's wood-basket will continue to be a major jobs and economic contributor for our future.

Finally, the coming year will continue the work of the Senate Select Committee on Intelligence in the ongoing investigation of Russian interference in the 2016 election. Our Committee has held seven public hearings and numerous classified sessions, reviewed tens of thousands of pages of documents and conducted hundreds of interviews. I remain focused on the security of our elections and committed to developing strategies to prevent interference by foreign governments in our democracy.

May 2018 be a good year for you, your family, your community and our great State.

**Annual Report to the Town of Sebago
A Message from Senator James Hamper**

Dear Friends and Neighbors:

I would like to thank you for the opportunity to represent you in the Maine Senate. It has been an honor to work on your behalf to make our state an even better place to live, work and conduct business.

On August 2, Maine lawmakers finally adjourned for the year, after what proved to be the longest session in recent memory due to a brief government shut down over budgetary disagreements. While no state budget is ever perfect, the end product was a state budget that makes a record investment in our students, supports our communities and will tremendously benefit small businesses and our economy.

Perhaps the most significant action the Legislature took last year, as part of the biennial budget, was the removal of the burdensome, job-killing surtax that was already hurting small businesses, doctors and other professionals that we so critically need. In November 2016, voters sent a clear message that education funding was to be a priority of the 128th Legislature, and we heard that message loud and clear. However, the funding mechanism which was included in the measure – the surtax – presented a serious threat to the state's economy. This new tax gave Maine the ominous distinction of being the highest-taxed state in the country and primarily impacted small businesses, which are the backbone of our economy, taxing them at a rate that is higher than larger corporations are subject to pay. I am proud to say that after much hard work and negotiating, thanks to our rebounding economy, we were able to support our local schools at a level we have never been able to before – without any additional taxation.

The Homestead Exemption, which provides much-needed property tax relief for homeowners, was also preserved in the budget with an increased exemption of \$20,000.

The Legislature also passed a measure to make Maine compliant with the REAL ID Act. As a result of this important new law, the federal government has granted Maine a waiver, meaning that Maine citizens can continue to use their driver's licenses to board commercial airplanes and access certain federal buildings.

While we accomplished much, there is still a lot of work ahead of us next session. Again, thank you for putting your trust in me to represent you in Augusta. 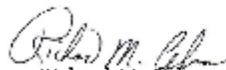

Management's Discussion and Analysis

Town of Sebago
For the Year Ended June 30, 2017

As Town Manager of Sebago, I offer the readers these financial statements this narrative overview and analysis of the financial activities of the Town for the fiscal year ended June 30, 2017.

Financial Highlights

Financial highlights for the past year include the following:

- The Town's assets exceeded its liabilities by \$6,747,325 at the close of the fiscal year. Of this amount, \$4,260,673 is unrestricted and may be used to meet the Town's ongoing obligations to citizens and creditors.
- The Town's total net position increased by \$132,931 as a result of operations throughout the fiscal year, or 2.01%.
- At the end of the fiscal year, the Town's governmental funds reported combined ending fund balances of \$4,065,083, an increase of \$246,782 from the prior fiscal year. Of this, \$1,984,013 is unassigned and available for spending at the Town's discretion from the General Fund.
- At the end of the fiscal year, the net increase in the General Fund's fund balance was \$68,061, or 2.99%.

Overview of the Financial Statements

The Town's basic financial statements have three components: government-wide financial statements, fund financial statements, and notes to the basic financial statements. The annual financial statements also contain required and other supplementary information.

Government-wide Financial Statements

Government-wide statements are designed to provide readers with a broad overview of the Town's finances, in a manner similar to a private-sector company.

The *Statement of Net Position* presents information on all of the Town's assets and liabilities, with the difference between the two reported as net position. Over time, increases or decreases in net position may serve as a useful indicator of whether the financial position of the Town is improving or deteriorating.

The *Statement of Activities* presents information showing how the Town's net position changed during the fiscal year. All changes in net position are reported as soon as the underlying event giving rise to the change occurs, regardless of the timing of related cash flows. Thus, revenues and expenses are reported in this statement for some items that will only result in cash flows in future fiscal periods (for example, accrued salaries).

In the government-wide financial statements, the Town's activities are reported as *governmental activities*, which encompass general government, public safety, public works, recreation and culture, welfare and social services. The Town does not currently report any business-type activities.

Fund Financial Statements

A *fund* is a grouping of related accounts that is used to maintain control over resources that have been segregated for specific activities or objectives. The Town uses fund accounting to ensure and demonstrate compliance with the intended purpose of the fund and the proper use of its designated resources. The Town's funds are divided into two categories: governmental funds, and fiduciary funds.

Governmental funds are used to account for essentially the same functions reported as governmental activities in the governmental-wide financial statements. However, unlike the governmental-wide statements, governmental fund financial statements focus on the near-term inflows and outflows of spendable resources, as well as on balances of spendable resources available at the end of the fiscal year. Such information may be useful in evaluating a government's near-term financing requirements.

Fiduciary funds are used to account for resources held for the benefit of parties outside the Town. Fiduciary funds are not reflected in the governmental-wide financial statement because the resources of those funds are not available to support the Town's own programs.

Because the focus of governmental funds is narrower than that of the governmental-wide financial statements, it is useful to compare the information presented for governmental funds with similar information presented for governmental activities in the governmental-wide financial statements. By doing so, readers may better understand the long-term impact of the Town's near-term financing decisions. Reconciliations are provided between the fund financial statements and the government-wide financial statements to assist in this comparison.

Current assets increased by 4.6% overall, and almost \$300k of the net \$192k increase was in cash and cash equivalents. Taxes receivable dropped by almost \$100k, indicating an improvement in tax collections during the year.

Net capital assets decreased during the year as a result assets depreciating faster than the Town is adding to them. During the year, depreciation expense was \$235,585 while the Town only added \$208,016 in new capital assets. Additionally, the Town traded in an old truck for a new truck that had not been fully depreciated. The trade-in value was \$8,670 less than its carrying value, thus creating a loss on disposal.

Both current liabilities and long-term liabilities saw a decrease in their balances during the year. This is largely to due to timing of payables at year end as well as the continued pay-down on the Town's single capital lease obligation. The Town currently has no long-term debts.

Most of the Town's net position (63%) is unrestricted and available to provide goods and services to the citizens of the Town. Net investment in capital assets (land, buildings, equipment, and infrastructure) make up 37% of total net position and represent the Town's net investment in long-term assets to help deliver goods and services.

The 2016 current liabilities and unrestricted net position shown above are restated from the prior year's financial statements due to a misclassification of a liability in the prior year. Current liabilities were overstated last year by \$3,891, which meant net position was understated. The restatement, therefore, increases 2016 net position from what was previously reported.

Overall, total revenue was down by \$457,814 in fiscal year 2017 compared to the prior year. Mostly, this was a combined result of decreases in assessed property taxes (down \$261,621 from FY16) and due to net sales proceeds from foreclosed properties in FY16, totaling \$169,950, that was a one-off occurrence and not repeated in FY17.

Total expenses were down by \$60,154 compared with the prior year. Pretty much all of the decrease was due to a lower assessment from MSAD 61 in FY17 than was assessed in FY16 (a reduction of \$92,949). Expense increases and decreases in other areas generally offset each other with the largest increases occurring in the General Government and Public Safety departments (\$19,373 and \$26,652, respectively).

The net result was a net increase in position in FY17 of \$132,931, which represents a 2.0% increase in total net position from the prior year.

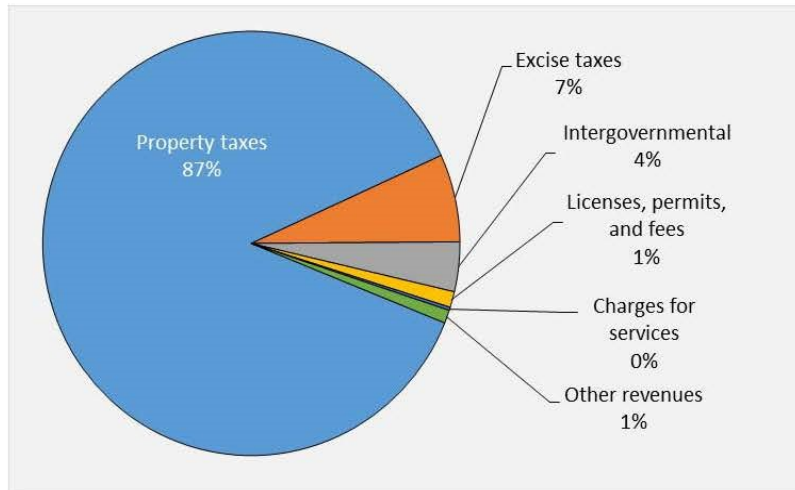

Financial Analysis of the Town's General Fund

The following schedule presents a summary of the General Fund's revenues for the fiscal years ended June 30, 2017 and 2016. Note that the revenues recognized in the General Fund differ from the revenues recognized for total governmental activities (see Table 2 above) due to (a) differences in measurement focus and accounting basis, as described in Note 1 to the financial statements, and (b) the fact that the General Fund revenues exclude revenues recognized in other funds. General Fund revenues focus on current financial resources available to provide goods and services of basic Town operations.

Property taxes make up 87% of the Town's General Fund revenues, with excise taxes being the next highest with 7%. The other sources of revenue make up the remaining 6% of the total.

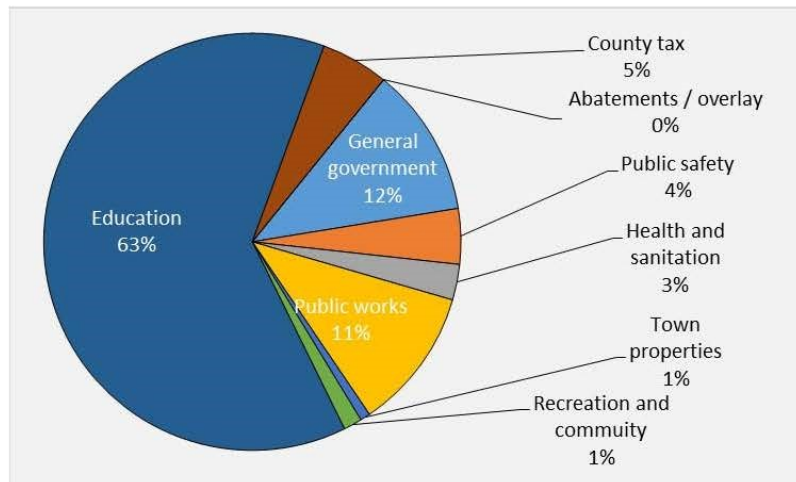

Management's Discussion and Analysis

The following schedule presents a summary of the General Fund's revenues for the fiscal years ended June 30, 2017 and 2016. Note that the expenditures recognized in the General Fund differ from the expenses recognized for total governmental activities (see Table 2 above) due to (a) differences in measurement focus and accounting basis, as described in Note 1 to the financial statements, and (b) the fact that the General Fund expenditures exclude expenditures recognized in other funds. General Fund expenditures focus on the consumption of current financial resources in providing goods and services of basic Town operations.

Education expenditures take up 63% of the total, while the next three largest categories of expenditures are for general government (12%), public works (11%), and county tax (5%). The remaining departments and categories (e.g., public safety, recreation, etc.) consume only 9% of total general fund expenditures.



For the Year Ended June 30, 2017

As of June 30, 2017, the General Fund's fund balance was \$2,346,062, up \$68,061 from the prior year. The fund balance is broken down into two components at year end: assigned and unassigned. The assigned portion, \$362,049, represents the amount of fund balance that the Town has budgeted to use in fiscal year 2018 plus carry forwards and amounts assigned to install dry hydrants. The unassigned portion, \$1,984,013, represents the net of all assets and liabilities that is not assigned. Basically, the unassigned portion represents the accumulated surplus of the General Fund that can be used for any purpose.

Budgetary Analysis of the General Fund

The General Fund is the only fund for which a legal budget is adopted. The original budget is approved at the annual town meeting and can have updates throughout the fiscal year due to statutorily required additions or reductions or due to special town meetings where additional appropriations may be approved.

During the year, the Town's total final budgeted expenditures and transfers out from the General Fund were \$5,401,710. The Town finished the fiscal year with total expenditures and transfers out coming in at \$5,133,162. Thus, expenditures and transfers out came in under budget by \$268,548 (or, roughly 5% under budget). Additionally, total revenues came in \$141,664 above estimates (\$5,059,230 estimated compared to \$5,200,894 actuals).

Departments that expended more than budgeted were as follows:

- Health and sanitation - \$9,687
- Recreation and community organization - \$4,959

Overall, the General Fund realized a surplus of \$68,061 despite having budgeted to use fund balance totaling \$342,480.

The Town's Other Governmental Funds

The only major fund, other than the General Fund, that the Town presents separately is the Capital Projects fund. This fund ended the year with a committed fund balance of \$1,623,687. The Capital Projects fund accounts for the various individual capital projects approved to be funded through tax levies. At year end, there were 34 different accounts within the Capital Projects fund that are being accounted for.

The fund's balance at the beginning of the year was \$1,450,828. During the year, the Town transferred in from the General Fund a total of \$324,291 to be added to the individual accounts. Additionally, the fund earned interest totaling \$8,765 during the year. During the year, the Town made expenditures from the fund for their designated purposes: \$143,016 from the *Plow Truck # 2* account, \$6,296 from the *Municipal Building* account, \$9,891 from the *Town Hall Parking Lot* account, and \$994 from the *Transfer Station Enhancements* account.

The remainder of the Town's governmental funds are considered non-major. These consist of the EMS Daytime Rescue fund, the Fuel Assistance fund, the FEMA Homeland Security fund, and a few other small funds. Their combined revenues during the year totaled \$51,808, most of which was from charges for services in the EMS Daytime Rescue fund. Total expenditures from these other governmental funds were \$45,946 – the vast majority of it being expenditures from the EMS Daytime Rescue fund for wages. All told, the non-major governmental funds began the year with fund balances totaling \$89,472 and ended the year with fund balances totaling \$95,334.

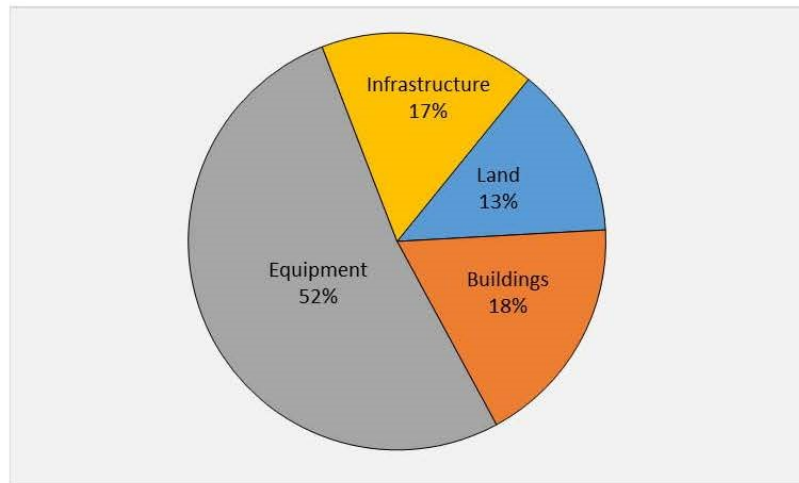
Capital Assets

At year end, the Town carried \$2,474,098 in land, buildings, equipment, and infrastructure on its books. This amount represents the historical cost of the assets less accumulated depreciation. Depreciation expense is the allocation of the cost of assets over the course of their useful lives. The table below shows the Town's general capital assets, net of accumulated depreciation, as of June 30, 2017 and 2016.

Changes in capital asset balances from FY16 to FY17 are the net result of capital additions totaling \$206,016, disposals of assets with a net book value of \$46,670, and depreciation expense totaling \$235,585.

The disposal of assets mentioned above was part of a new asset purchase where \$38,000 was given in trade-in value for the disposed-of asset. Thus, a loss of the disposition was recognized for \$8,670. In addition to this, minor assets that were not on the capital asset list were sold for a total of \$329. Therefore, on a full accrual basis, the Town recognized as net loss on disposal of assets totaling \$8,341.



For the Year Ended June 30, 2017

Economic Factors and Next Year's Budget and Rates

At its annual town meeting in June, the townspeople approved municipal appropriations for FY 2018 totaling \$2,175,403. This represents a 7% increase over the FY 2017 approved municipal appropriations. Of the FY 2018 appropriations, a total of \$163,500 was approved to be sourced from the General Fund's fund balance in order to reduce the amount of the tax levy. In addition, the townspeople approved carrying forward unexpended road funds, which adds to the total approved appropriations by \$175,075, the county assessed the Town \$253,257 for county taxes, and MSAD 61 assessed the Town \$3,091,581 for education. Total original budgeted expenditures for FY 2018, therefore, are \$5,965,316, which equals an 11.3% increase compared to the FY 2017 final budget.

The total tax levy for FY 2018 is \$4,741,438, which translates to a \$12.95 mill rate (an increase of \$0.65 from FY 2017).

In November, 2017, the townspeople approved a vote to withdraw from MSAD 61 and provide education through a department of the Town. In two prior referenda, the Town had approved \$50,000 total for School Withdrawal Committee expenditures. At year end June 30, 2017, the unexpended balance of these amounts was \$19,584. Since July 1, 2017, a further \$18,883 has been expended, leaving \$701 available. Another referendum will be held in February 2018 asking voters for another \$25,000 to cover expenditures until the school budget can be voted on in June.

From the desk of the Town Manager

Who ever said “initiation by fire” knew exactly what they were talking about, and this first year initiated me well. Each event brought a lesson to be learned, a new experience or expanded my problem-solving skills.

Probably the most important things I’ve learned are “you have to listen to people” and “you can’t do it alone”.

On to business.... Last summer the Town Crew was busy reconstructing Anderson Road. It is estimated that the town saved approximately \$350,000 by completing this project versus having contracted it out. It may have seemed like a long event, but I believe the end result was well worth the wait. The next road project will be Hogfat Hill Road, followed by Hawkes Road. Keep in mind we have a limited crew, and a great job takes time, please be patient with us.

Other projects completed included:

- Paint recycling is now available at the Transfer Station at no additional costs to the Town.*
- Minor improvements were made to the Town Hall*
- Repairs were made to the Historical Building*
- Several contracts were re-negotiated in an effort to save the town money and provide better services.*

Late October, Mother Nature unleashed her fury and produced a storm which had many of us remembering the power of the ice storm of “98”; phone and internet services were out throughout most of the town for several days. As so often has occurred in the past, Sebago’s citizens have proven once again that we are tough and we shall persevere. Thank you to all who cleared the roads, opened and supervised the shelter, checked on their neighbors and kept us safe.

On November 7th, the town took the final step in withdrawing from the school district. Sebago will now have a final say in every aspect

of how our children will be educated. This is a momentous step not only for our children, but for the Town and our future as well.

This winter the Capital Improvement Program Committee (CIP) met for several weeks prioritizing vehicles and projects for the upcoming budget year. This program allows the town to prepare for the replacement of vehicles and plan for projects without the need of borrowing funds or leasing vehicles, unless however an emergency arises. The committee has worked very hard to continue on a schedule with little to no increases to the municipal budget.

The Budget Committee has met and has created a very manageable budget that is comparable to past years. Unfortunately, there are always unknowns as we rely on funds from the State while creating our budget. Sometimes these funds no longer exist after the budget has been approved. Rest assured that both of the committees, the Board of Selectmen, Department Heads, and myself have nothing but your best interest in mind.

Sebago is very fortunate to have very dedicated and experienced people working for them. The amount of dedication that the employees provide in keeping this town running is unsurmountable. I can not thank them enough.

I would also like to thank all the volunteers that serve on the various boards and committees, your participation is invaluable. Thank you to everyone that "pitched in" and helped out to make sure the recreation programs continued. I couldn't have done it without you.

I have sincerely appreciated your patience as I learn this new position and look forward too many more years of service.

SELECTMEN REPORT

The Board of Selectmen welcomed Michele Bukoveckas as the new Town Manager as of July 1, 2017. After months of screening applicants and conducting interviews under the guidance of consultant, Neal Allen, we feel the best choice was made for the Town of Sebago. The Town will continue to thrive under her dedicated work ethic and knowledge of municipal affairs.

We continue to pursue our goals of further maintenance to the town buildings, especially the Town Hall building. Heating and kitchen upgrades, painting, and refinishing the gym floor are ongoing projects. Cost saving energy is being addressed with new lighting in the Town Office, as well as a solar array project on the sand and salt shed, which is currently in the planning stage. The Capital Investment Program continues to be an invaluable source for these projects.

The Road Committee and Public Works Crew are on track with their road plan. Anderson Road was completed as planned, and the .7 tenths miles of Hogfat Hill Road will be done this year. This spring the gravel portions of Folly Road and Anderson Road will be upgraded with monies currently in the paving/reconstruction part of the budget.

Cemetery work is ongoing with stone repairs, along with the goals of replacing the fence at the Peabody Cemetery and repairing the Fitch Cemetery wall behind the Library. Haley Cemetery has been deeded over to the Town and an old cemetery has been revived on Route 107 with the return of an old stone to the Town. The stone was reset and the cemetery is now known as the Cole Gravesite.

The Board thanks Code Enforcement Officer, Brandon Woolley for bringing our Land Use Ordinance in line with State mandates. We also appreciate his expertise in guiding the Planning Board and Board of Appeals.

Thanks go to the office staff that has transitioned into their new positions so professionally. The Town is growing and doing well financially thanks to all who make it work so well!

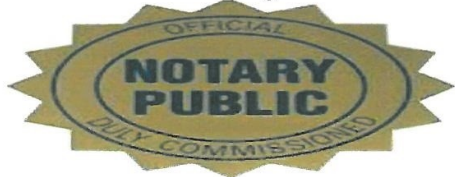

PUBLIC WORKS DEPARTMENT

To the Citizens of Sebago:

The Public Works Department partners with George Anderson & Sons, Inc. to provide the Town of Sebago Citizens with Highway Maintenance; independently providing both Vehicle and Building Maintenance. The Department consists of 3 full-time employees and a Public Works Director who have a combined total of 64 years of experience.

In the summer months, our team performs tasks such as grading and ditching roads, replacing culverts and cutting brush. In the fall, we get our winter sand and salt ready and ensure that the plow trucks are ready for the upcoming winter season. In between storms we remove snow and ensure storm drains are clear to eliminate the possibility of flooding and road erosion. In the spring, our tasks include street sweeping, ditching and overall storm cleanup.

Our department is responsible for the town-owned beach which includes getting it ready for use in the spring and maintaining the area throughout the summer months. We are also responsible for the maintenance of the town-owned building(s), setup and maintenance of the ice rink located at the school, setting up for events and preparing the town for the Fourth of July celebration.

This year the team reconstructed and prepared the Town Office parking lot for new pavement. This project was completed within the allocated timeframe of 3 weeks. Anderson Road had $\frac{3}{4}$ of a mile reconstructed with gravel and new pavement which was completed in 4 months. Each year the goal is to tackle a few sections of road for construction. In 2018 Hogfat Hill Road will have $\frac{6}{10}$ ths of a mile completely reconstructed and Folly Road will be resurfaced from 114 to the area known as the school bus turnaround. These projects will include new culverts and ditching efforts.



In closing, our team worked tireless hours to ensure that the roads in Sebago were the safest and most drivable roads out of all the surrounding towns and in my opinion, our mission was accomplished. The Public Works Department and George Anderson's Crew will continue to work hard for you and your community.

SEBAGO EMS

To the Citizens of Sebago:

I would like to open by thanking those who made donations to Sebago EMS in the last year. We continue to strive to provide high quality prehospital emergency care to the citizens of the town and cannot do so without your support. It is very much appreciated.



We improved our in-house documentation this winter by phasing out paper documentation. We now document our apparatus, equipment, and station checks using Zoll Checklist on IPads which allows us to easily review and store our essential documentation. This documentation is available to the officers at the touch of a button as it is stored electronically. Documenting and storing our records in this manner reduces waste, reduces the need for cabinet space in our stations, and saves the town money. Time will tell how much money this saves but ultimately this system should reduce wear and tear on the printers in the stations as well as decrease the use of paper and ink.

Sebago teamed up with Naples and Casco to bring state level EMS continuing education to the region this year. Once a month a state instructor comes to the Naples and all three towns participate in training together. This not only brings quality instructors to the region but saves money for each town but fosters a sense of community within the three services.

In February 2018, 2 of our members participated in a Tactical Emergency Casualty Care class. This is a nationwide class which teaches responders how to provide care in a civilian tactical environment (also known as an active shooter situation). Topics covered were direct threat care (care under fire), indirect threat care (the situation is not yet stable but no active shooter is present) and evacuation care. Topics covered included control of hemorrhage, advanced airway management, care of wounded responders, care of pediatric patients, and techniques for dragging victims to safety. We hope to never need our new training but rest assured that we will use it if needed.

Sebago EMS worked with the Naples and Casco fire Departments to collect gently used coats, hats, gloves, and mittens again this past Christmas season. We wish to thank everyone who donated and helped to keep our neighbors in the Lake Region warm during the brutal cold spell we had this winter. Please consider us next year when your children have outgrown this year's coats. The donation box is located at the EMS building or you can contact any member to make a donation.

However, due to the income levels and the struggles we have in the town we made this conscious decision. Boy did it work! We have this year a full Tball team, Rookies, Minors and a U8 & U10 team. GENERAL ASSISTANCE

I have been doing General Assistance here in Sebago since 2011. Having to go by the State's rules and regulations is not always easy. The rules are updated every year and the Town must adopt (22 MRSA, §4031 (5). Each year we are supposed to be audited by the State.

General Assistance hours are on Tuesday from 1PM to 3PM. For any client that cannot make it, they may call the office for a time that works best for them.

Each client must bring in proof of all income, expense and a current bank statement for the last 30 days for everyone in the household. If members of the household are able to work and are currently without a job, they must bring proof that they have been looking for work. This needs to be verified.

The budget this year was \$10,575. We spent \$2,500 for administration, \$327.70 for heat, \$333 for rental, \$785 for burial and \$825 for holiday assistance. General Assistance spent a total of \$4,770.70 leaving a balance of \$5,804.30.

FUEL ASSISTANCE PROGRAM

This program is now going on six years, thanks to many generous donations and fund raisings. Our thanks go out to Camp O-AT-KA for the harvest dinners they have put on for us, at no expense to us. Many items were donated by local residents and were raffled off at the dinner. Because of all of this we are able to help with heat for those who are not eligible for General Assistance, but are still in need.

As in years past, Spaulding Memorial Library had a very active schedule of events during fiscal year 2016-2017.

One of the many programs sponsored by Spaulding Memorial Library, Push Back the Stacks annually presents free family events. In July, as part of this program, singer, songwriter, and musician Jennifer Armstrong played many instruments, sang many songs, and told many stories.

Wildly popular, Peter Mezoian with his Outrageous Banjo was a highlight in August.

In September, former Maine game warden Roger Guay was as entertaining as he was informative about life as a game warden as well as a trainer of dogs serving with game wardens.

Work on the library continued with the refinishing of the floors in November and December. Old panels were removed from the library's windows, the windows washed, and new panels installed. Things are brighter now!

Take Your Child to the Library Day in February 2017 was celebrated in fine form with a story, crafts, games, and treats, all with a football theme. Free vision screening for children was also offered by the Sebago Lions.

From September through May, the library sponsors a monthly Book Discussion Group, open to any adult who likes a lively and fun conversation about each month's selection. (No need to buy each month's book, we get copies interlibrary.)

Potter Trust mission: "Board shall have, receive, hold and manage the money received under the testament and will of Dr. Joseph F. Potter for certain educational, charitable and religious objects and purposes."

In March of last year, the trust distributed funds to Sebago Elementary (\$300 for a small set of Digi Blocks), the Sebago Church of the Nazarene \$250 and \$250 to a local charity "Making Holiday Wishes."

Our annual meeting occurred on February 21. Copies of the invested CD certificates and the checks distributed last March were reviewed. A recommendation for a 2018 distribution was discussed. Unfortunately only three trustees could attend. So no action will be taken this year. The two CDs' will roll over for one year on March 11.

SEBAGO HISTORICAL SOCIETY

The Sebago Historical Society meets on the 3rd Wednesday of each month at 7 PM. During the warmer months, May through September meetings are held at the Historical Society building (the former Free Will Baptist Church built in 1844) located at 347 Convene Rd. During the colder months, October through April they are held at a member's house. As always, all meetings are open to the public. We welcome visitors to view our displays and research family history during our summertime open hours, which are on the 3rd Wednesday of each month from 2 PM to 7 PM, before our monthly meeting.

Many services are provided to the citizens of Sebago and others interested in our town history. We are always happy to visit the elementary school children, bringing displays to them, or having them visit our building to view our exhibits and participate in hands on history lessons. Notebooks of family histories are available, with genealogical lines of ancestors, which were donated by family members or completed from our own research.

The theme for the 2018 Sebago Historical Society calendar is again Neighborhoods of Sebago, this year featuring North Sebago. The calendars are a source of historical information about our town, its citizens and life in an earlier time. This calendar is our major source of income, and provides area businesses with the opportunity to advertise their business or service.

We had a number of public speakers in 2017, including a Public Presentation by Dave Tanguay of Windham Historical Society on the Cumberland and Oxford Canal which ran between Sebago Lake and the ocean via the Presumpscot River. An Antiques Roadshow with antiques appraiser and collector, Glenn Grant of Sebago. This program was a huge success with folks from Sebago and neighboring towns bringing items to be appraised. We held an Open House in September, inviting the public to visit our display shed that houses larger items. Demonstrations of cider making with a hand cranked machine, homemade ice cream, spinning wheel demonstration, and a 1800's sock knitting machine demo were the main features. Our Veteran's Day Project featured speaker Walt Bannon talking about the book he wrote about his mom's experiences as a WW II war bride. We invited a number of local women who were war brides to speak about their experiences. We also solicited photos of Sebago's veterans, past and present to display as a slide show for this event. It was filmed by Lake Region TV and is available for viewing on our website www.sebagohistoricalsociety.com. We are still collecting photos of veterans, not only those who enlisted from Sebago, but also anyone who has lived in Sebago and is a veteran. Please contact a member of the historical society or inquire at the library. We partnered with the Rufus Porter Museum in Bridgton at our open house about the Jonathan Poor house on Hillside. He was the nephew of famed early 1800's muralist Rufus Porter, and an itinerant muralist himself.

As always we had a booth at Sebago Days with our calendars and historical books, postcards and maps available for sale.

New members interested in helping to achieve our goals and those interested in researching and learning of Sebago's past are always welcome. Membership information can be found on our Facebook page, Sebago Historical Society – LIKE us please, and on our website. No one is too young or too old to become a member and learn something new about something old.
