GOVERNOR

Dear Citizens of Maine:

For the past eight years as your Governor, my priority has been to make Maine prosperous. I am proud to say that my administration has had some success, but there is more that can be done.

Mainers experienced strong, record-setting economic growth in 2018, setting so many new records: a record-high number of employers; a record-high number of private-sector jobs; record-high revenues for the state; record-low unemployment; and the fastest net-earnings growth in New England. Our poverty rate declined to the lowest since 2005 with the fewest number of children in poverty in 17 years. Maine's future is the brightest it has been in decades: there's more new businesses, more money in your paycheck, and better opportunities for our children. And that's what it's all about: the future of our state.

We have brought stability to state finances and implemented pro-business, pro-growth policies across state government. The incoming administration is taking on a state government that is vastly improved—both structurally and financially—from the one I inherited. Therefore, I have suggested to the new administration that now is the time to cut taxes by an additional 20 percent.

My administration lowered taxes by 20 percent for more than half-a-million Mainers. Cutting taxes for our families has proven to be an excellent policy decision. Despite this cut, we are seeing higher revenue in almost every tax category—sales and use tax, individual income tax, and corporate income tax. We must always remember that the revenue we receive in taxes is due to the hard work of Maine's people. Democrats stated they want to use surplus money to fully fund revenue sharing at 5 percent, rather than the 2 percent the towns have received for the past 6 years. However, there is no guarantee your local government will cut your property taxes by one penny—never mind dollar-for-dollar—if revenue sharing is increased.

The people of Maine and the municipal balance sheets would be better off if the state cut income taxes and allowed municipalities to collect property taxes or service fees from non-profits to supplement the local property taxes. Everyone should contribute to the operation of local community governments.

I encourage you to pay attention to what happens in your municipality and in Augusta. So many good people have worked much too hard to achieve our current prosperity. We must avoid letting politicians drive Maine's finances and its economy back into the ground. I promise you that I will be watching.

Dear Friends,

I hope this message finds you well. I am honored to represent you and your family and am grateful for the chance to offer both an update from Congress and my thoughts on the year ahead.

In Maine, we care less about political parties than about getting the job done. That's why I'm happy to report several recent victories I had reaching across the aisle to address issues important to our state.

Signed into law after months of deadlock, the 2018 Farm Bill contained several provisions l introduced. We were able to boost local food investment and organic research programs that are important to the Maine farmers driving a resurgence in our agricultural economy. The bill also created a pilot program to help doctors write prescriptions and offer vouchers to patients who need to change their diet but can't afford fresh food. Finally, the legislation included several steps I introduced to reduce food waste, a national problem that is not only costly to the environment and economy, but a missed opportunity to help millions of Americans who don't have enough to eat.

At the end of 2018, the President signed into law legislative language I introduced to assist veterans who had been blindsided by debt with the Department of Veterans Affairs. After hearing from several veterans who did not receive mailings about their debt until it was too late to take action, I introduced a bill to require the VA to improve its notification system. The final legislation requires that veterans have the option of getting electronic notifications and that the VA report on the underlying issues.

And on the House Appropriations Committee, I worked to protect programs that our state relies on, such as small business grants, rural broadband investment, effective responses to the opioid epidemic, shipbuilding at Bath Iron Works, and more.

As a new Congress gets underway, I will keep working with Republicans to make progress on key issues like these. But with Democrats now in the majority, I look forward to having an open debate on problems that have been ignored for too long. This includes the gun violence plaguing our nation, the dangers climate change presents to our country, crushing student loan debt, the influence of big money in politics, and the need for all Americans to access affordable health care and prescriptions.

In Washington and Maine, my offices stand ready to answer your questions, listen to feedback, and assist with federal issues and agencies. My bard-working staff helps many hundreds of constituents every year and I welcome the chance to serve you.

Dear Friends,

It is an honor to represent Maine in the United States Senate. I am grateful for the trust the people of our state have placed in me and welcome this opportunity to share some key accomplishments from this past year.

As Chairman of the Senate Aging Committee, I worked to help ensure the well-being of our seniors. The Senior Safe Act I authored became law last year and is empowering banks, credit unions, and other financial institutions to better protect seniors from financial fraud.

Following extensive committee investigations of prescription drug pricing, additional legislation I crafted became law, ending the egregious practice of pharmacy "gag clauses" that prevented pharmacists from informing patients on how to pay the lowest possible price.

This year, I was also successful in securing an extra \$425 million for Alzheimer's research—the largest funding increase ever—bringing the total to \$2.34 billion. Additionally, the bipartisan *BOLD Act* I authored will create public health infrastructure to combat Alzheimer's by promoting education, early diagnosis, and improved care management.

More than 40 million Americans—including 178,000 Mainers—are caregivers for parents, spouses, children, and other loved ones with disabilities or illnesses, such as Alzheimer's. The *RAISE Family Caregivers Act* I authored was signed into law last year, giving caregivers more resources and training to better balance the full-time job of caregiving. Another law I wrote will help grandparents who are raising grandchildren, largely due to the opioid addiction crisis.

In addition to helping seniors, a major accomplishment over the past year is the increased federal investment in biomedical research that is leading to progress in the fight against numerous devastating diseases. Congress has boosted funding for the National Institutes of Health by \$7 billion in just the last three years, bringing total funding to more than \$39 billion.

One of my highest priorities as Chairman of the Transportation Appropriations Subcommittee is to improve our nation's crumbling infrastructure and ensure that Maine's needs are addressed. Since the Better Utilizing Investments to Leverage Development (BUILD) Transportation Grants program, formerly known as TIGER, was established in 2009, I have secured \$160 million for vital transportation projects throughout Maine.

Congress also delivered a Farm Bill last year, which includes many important provisions that will help the agriculture industry in Maine and across the country. Specifically, I secured provisions that will strengthen support for young farmers, improve local farm-to-market efforts, and increase funding for organic research.

Congress took decisive action to address the opioid addiction epidemic. In addition to appropriating \$8.5 billion in federal funding last year, Congress enacted the SUPPORT for Patients and Communities Act, a comprehensive package that embraces the multipronged approach I have long advocated for this epidemic: prevention, treatment, recovery, and enforcement to stop drug trafficking.

Maine plays a key role in ensuring a strong national defense. In 2018, Congress provided funding for five ships to be built at Bath Iron Works, which will help to keep our nation safe and provide our skilled shipbuilders a steady job. I also secured more than \$162 million for infrastructure projects at Portsmouth Naval Shipyard to support their important work to overhaul Navy submarines.

A Maine value that always guides me is our unsurpassed work ethic. In December 2018, I cast my 6,834th consecutive vote, continuing my record of never missing a roll-call vote since my Senate service began in 1997.

Dear Friends,

As I travel Maine, I hear from people who live in every corner of our state. I hear about their achievements, their successes, their work to improve their communities – I hear about the hope they have for our state. I also hear about our challenges, and all the work we have left to do. As I see it, that's my jeb: to listen to you, act where I can to build on what's good, and work on the tough parts. As 2018 comes to a close, I wanted to take a moment to share an update on some of the work we're doing in Washington to lift up the accomplishments of Maine people and make progress on the challenges they face.

From Portland to Presque Isle, from Milo to Caraden, I hear about the pain that the opioid epidemic is inflicting on Maine communities. I've met with Maine people in recovery, family members of those struggling with substance use disorders, treatment providers, and law enforcement officials to learn about their experiences with this terrible disease, and everyone agrees that in order to fully respond to these problems, we need a stronger federal effort to end the opioid epidemic. Fortunately, some help is on the way – in October, we overwhelmingly passed a sweeping, bipartisan opioids bill. I've pushed hard for this type of legislation and was proud to have provisions I've advocated for included in the bill. These priorities have been guided by the voices of Maine people, and we'll keep working to confront this tragic problem.

I've also worked to strengthen the future of our forest economy. Maine's forests have powered our state's economy for generations, especially in our rural communities. So, when rapid shifts in the market led to the closure of many pulp and paper mills and biomass power plants, it required a collaborative approach to support future growth in this important industry. That's why, together with the other members of the state's Congressional delegation, I pushed to establish the Economic Development Assessment Team (EDAT). This integrated, multiagency effort aims to foster innovation and commercialization in Maine's forest economy, and we're already seeing the benefits: in recent months, several forest industry businesses have announced significant investments into Maine operations, and in September 2018, the Forest Opportunity Roadmap (FOR)/Maine released an action plan to make sure this industry, and the rural communities it supports, can continue to thrive for generations to come.

As I close this letter, please allow me to express my gratitude to each of you – for your dedication to our state, and to one another. It's often said that Maine is like a big small town (with very long streets) — that's because at our heart, we're one big community. It's not only a pleasure to serve you– it's a pleasure to know you. Thank you for being the reason Maine is so special. Mary and I hope that 2019 will be a good year for you, your family, your community, and our great State.

Dear Friends and Neighbors:

Let me start by thanking you for the honor to serve you in the Maine Senate. It has been an immense privilege for me to represent you in the Senate the past several years. This term marks my fourth and final term in the Maine Senate. When concluded, I will have completed sixteen total years of service in the Maine Legislature.

Following the November elections, the newly-elected 129th Legislature was sworn-in on December 5, 2018. One of the very first acts of this legislature was presiding over the inauguration of Governor Janet Mills. The Mills Administration has inherited a strong Maine economy with record-low unemployment and a state budget that has had surpluses instead of shortfalls. After years of sound fiscal management, such as paying off the \$500 million Maine owed to our hospitals, our state is in a much stronger position financially. Maintaining sound fiscal policies will be a top priority of mine.

Many decisions for the first six months of this legislature will surround the makeup of the next two-year budget. For the third straight term, I have been appointed to serve on the legislature's budget writing panel, the Appropriations and Financial Affairs Committee. Making sure that we maintain a state government that Mainers can afford will be a primary focus for me.

The current budget gave an historic increase in funding to K-12 education. Finding a way to maintain the increased funding along with funding other programs, including municipal revenue sharing and Medicaid expansion, will be the challenge for this legislature; compromises will need to be found.

The opioid epidemic continues to devastate our state and communities. Drug addiction affects Mainers from every walk of life: young to old, urban to rural, affluent to poor. Finding solutions that help quell the flow of these poisons into our state will be a priority for me. It is important that the legislature support treatment programs that have proven results for Maine families.

Management's Discussion and Analysis

Town of Sebago For the Year Ended June 30, 2018

As Town Manager of Sebago, I offer the readers of these financial statements this narrative overview and analysis of the financial activities of the Town for the fiscal year ended June 30, 2018.

Financial Highlights

Financial highlights for the past year include the following:

- The Town's assets exceeded its liabilities by \$7,110,141 at the close of the fiscal year. Of this amount, \$4,602,125 is unrestricted and may be used to meet the Town's ongoing obligations to citizens and creditors.
- The Town's total net position increased by \$362,816 as a result of operations throughout the fiscal year, or 5.4%.
- At the end of the fiscal year, the Town's governmental funds reported combined ending fund balances of \$4,370,061, an increase of \$304,978 from the prior fiscal year. Of this, \$2,002,005 is unassigned and available for spending at the Town's discretion from the General Fund.
- At the end of the fiscal year, the net decrease in the General Fund's fund balance was \$42,394, or -1.8%, from the prior fiscal year.

Overview of the Financial Statements

The Town's basic financial statements have three components: government-wide financial statements, fund financial statements, and notes to the basic financial statements. The annual financial statements also contain required and other supplementary information.

Government-wide Financial Statements

Government-wide statements are designed to provide readers with a broad overview of the Town's finances, in a manner similar to a private-sector company.

The Statement of Net Position presents information on all of the Town's assets and liabilities, with the difference between the two reported as net position. Over time, increases or decreases in net position may serve as a useful indicator of whether the financial position of the Town is improving or deteriorating.

The Statement of Activities presents information showing how the Town's net position changed during the fiscal year. All changes in net position are reported as soon as the underlying event giving rise to the change occurs, regardless of the timing of related cash flows. Thus, revenues and expenses are reported in this statement for some items that will only result in cash flows in future fiscal periods (for example, accrued salaries).

In the government-wide financial statements, the Town's activities are reported as *governmental activities*, which encompass general government, public safety, public works, recreation and culture, welfare and social services. The Town does not currently report any business-type activities.

Fund Financial Statements

A *fund* is a grouping of related accounts that is used to maintain control over resources that have been segregated for specific activities or objectives. The Town uses fund accounting to ensure and demonstrate compliance with the intended purpose of the fund and the proper use of its designated resources. The Town's funds are divided into two categories: governmental funds, and fiduciary funds.

Governmental funds are used to account for essentially the same functions reported as governmental activities in the governmental-wide financial statements. However, unlike the governmental-wide statements, governmental fund financial statements focus on the near-term inflows and outflows of spendable resources, as well as on balances of spendable resources available at the end of the fiscal year. Such information may be useful in evaluating a government's near-term financing requirements.

Fiduciary funds are used to account for resources held for the benefit of parties outside the Town. Fiduciary funds are not reflected in the governmental-wide financial statement because the resources of those funds are not available to support the Town's own programs.

Because the focus of governmental funds is narrower than that of the governmental-wide financial statements, it is useful to compare the information presented for governmental funds with similar information presented for governmental activities in the governmental-wide financial statements. By doing so, readers may better understand the long-term impact of the Town's near-term financing decisions. Reconciliations are provided between the fund financial statements and the government-wide financial statements to assist in this comparison.

Financial Analysis of the Town as a Whole

Current assets increased by 9% overall. This was combination of a \$427k in in cash and equivalents offset with a decrease of about \$41K in taxes and liens receivable.

Net capital assets increased during the year primarily due to the construction of the new Anderson Road, new vault room, and the office parking lot. During the year, depreciation expense was \$236,940 while the Town added \$256,369 in new capital assets.

Current liabilities saw an increase in its net balance during the year by about \$23k. This is largely to due to timing of payment of payables at year end. The Town's long-term liabilities are solely accrued compensated absences which fluctuate normally from year to year based on employees' unused vacation time.

Most of the Town's net position (65%) is unrestricted and available to provide goods and services to the citizens of the Town. Net investment in capital assets (land, buildings, equipment, and infrastructure) make up 35% of total net position and represent the Town's net investment in long-term assets to help deliver goods and services.

Overall, total revenue was up by \$359,299 in fiscal year 2018 compared to the prior year. Mostly, this was due to an increase in property taxes (up by \$259,261 from FY17) and excise taxes (up \$35,147 from FY17).

Total expenses were up by \$129,413 compared with the prior year. Pretty much all of the increase was due to a higher assessment from MSAD 61 (an increase of \$62,002) and in Other Expenses (an increase of \$62,421), which is primarily due to the Capital Improvements Fund's FY18 expenditures. Expense increases and decreases in other areas generally offset each other with the largest decreases occurring in the General Government and Recreation and Community (\$31,801 and \$11,141, respectively), and an increase in Public Safety of \$27,969.

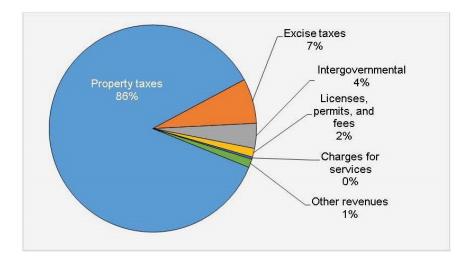
The net result was a net increase in position in FY18 of \$362,817, which represents a 5.4% increase in total net position from the prior year.

Financial Analysis of the Town's General Fund

The following schedule presents a summary of the General Fund's revenues for the fiscal years ended June 30, 2018 and 2017. Note that the revenues recognized in the General Fund differ from the revenues recognized for total governmental activities (see Table 2) due to (a) differences in measurement focus and accounting basis, as described in Note 1 to the financial statements, and (b) the fact that the General Fund revenues focus on current financial resources available to provide goods and services of basic Town operations.

Property taxes make up 86% of the Town's General Fund revenues, with excise taxes being the next highest with 7%. The other sources of revenue make up the remaining 7% of the total.

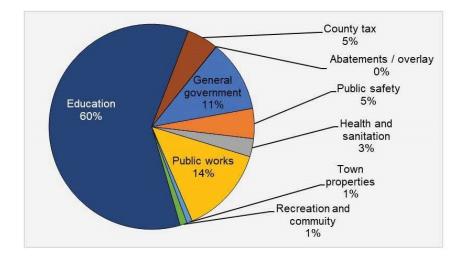


Management's Discussion and Analysis

The following schedule presents a summary of the General Fund's expenses for the fiscal years ended June 30, 2018 and 2017. Note that the expenditures recognized in the General Fund differ from the expenses recognized for total governmental activities (see Table 2) due to (a) differences in measurement focus and accounting basis, as described in Note 1 to the financial statements, and (b) the fact that the General Fund expenditures recognized in other funds. General Fund expenditures focus on the consumption of current financial resources in providing goods and services of basic Town operations.

Education expenditures take up 60% of the total, while the next three largest categories of expenditures are for general government (11%), public works (14%), and county tax (5%). The remaining departments and categories (e.g., public safety, recreation, etc.) consume only 10% of total general fund expenditures.



Management's Discussion and Analysis

As of June 30, 2018, the General Fund's fund balance was \$2,303,668, down by \$42,394 from the prior year. The fund balance is broken down into two components at year end: assigned and unassigned. The assigned portion, \$301,663, represents the amount of fund balance that the Town has budgeted to use in fiscal year 2019, the public works carry forward for roads, and other minor amounts assigned for specific future expenditure. The unassigned portion of \$2,002,005 represents the accumulated surplus of the General Fund that can be used for any purpose.

Budgetary Analysis of the General Fund

The General Fund is the only fund for which a legal budget is adopted. The original budget is approved at the annual town meeting and can have updates throughout the fiscal year due to statutorily required additions or reductions or due to special town meetings where additional appropriations may be approved.

The Town's original budget contemplated a \$358,159 deficit (commonly referred to as a "budgeted use of fund balance). In January 2018, a special town vote approved \$25,000 in additional expenditures for the School Withdrawal Committee to be funded from the unassigned fund balance. The result is that the Town's final budget was a budgeted deficit of \$383.159.

Total final budgeted expenditures were \$5,346,530. Actual expenditures were \$5,116,859, coming in \$229,671 under budget. Overall, the actual General Fund deficit came in at \$42,394, \$340,765 less than the budgeted deficit of \$383,159.

The Town's Other Governmental Funds

The only major fund, other than the General Fund, that the Town presents separately is the Capital Projects fund. This fund ended the year with a committed fund balance of \$1,956,404. The Capital Projects fund accounts for the various individual capital projects approved to be funded through tax levies. At year end, there were 36 different accounts within the Capital Projects fund that are being accounted for.

The fund's balance at the beginning of the year was \$1,623,687. During the year, the Town transferred in from the General Fund a total of \$394,343 to be added to the individual accounts. Additionally, the fund earned interest totaling \$17,177 during the year. During the year, the Town made \$78,803 in expenditures from the fund for specific capital purchases: \$12,473 from the *Municipal Building* account, \$28,670 from the *Town Hall Parking Lot* account, \$5,955 from the *Transfer Station Enhancement* account, \$9,263 from the *Server* account, \$2,045 from the *50 Yard* account, \$6,970 from the *Emergency Generator* account, and \$13,427 from the *Town Office Vault* account.

The remainder of the Town's governmental funds are considered non-major. These consist of the EMS Daytime Rescue fund, the Fuel Assistance fund, the FEMA Homeland Security fund, and a few other small funds. Their combined revenues during the year totaled \$55,630, most of which was from charges for services in the EMS Daytime Rescue fund. Total expenditures from these other governmental funds were \$40,975, the vast majority of it being expenditures from the EMS Daytime Rescue fund for wages. All told, the non-major governmental funds began the year with fund balances totaling \$95,334 and ended the year with fund balances totaling \$109,989.

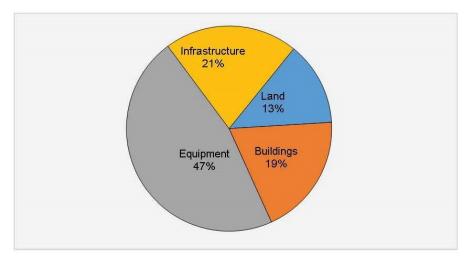
Capital Assets

At year end, the Town carried \$2,492,821 in land, buildings, equipment, and infrastructure on its books. This amount represents the historical cost of the assets less accumulated depreciation. Depreciation expense is the allocation of the cost of assets over the course of their useful lives. The table below shows the Town's general capital assets, net of accumulated depreciation, as of June 30, 2018 and 2017.

Changes in capital asset balances from FY17 to FY18 are the net result of capital additions totaling \$256,369, disposals of assets with a net book value of \$708, and depreciation expense totaling \$236,940.

The disposal of assets mentioned above pertains to the generator that was sold for \$850, and the replacement of the old server. Thus, a net gain of the disposition was recognized for \$142 on the full accrual basis.



Economic Factors and Next Year's Budget and Rates

At its annual town meeting in June, the townspeople approved municipal appropriations for FY 2019 totaling \$2,218,174. This represents a 9% increase over the FY 2018 approved municipal appropriations. Of the FY 2019 appropriations, a total of \$126,984 was approved to be sourced from the General Fund's fund balance in order to reduce the amount of the tax levy. In addition, the townspeople approved carrying forward unexpended road funds, which adds to the total approved appropriations by \$157,886. The county assessed the Town \$264,667 for county taxes, and the Town School Department's budget is \$3,168,870. Total original budgeted expenditures for FY 2019, therefore, are \$5,809,596, which equals a 10.5% increase compared to the FY 2018 final budget.

The total tax levy for FY 2019 is \$4,880,316, which translates to a \$13.15 mill rate (an increase of \$0.20 from FY 2018).

Effective July 1, 2018, the Town withdrew from MSAD 61 and established its own municipal school department. The Town, through the school department, will remain responsible for shared debts of MSAD 61 that were incurred before the effective date of the withdrawal. The capital assets related to Sebago Elementary School will be recorded and presented as capital assets of the Town beginning in fiscal year 2019.

From the desk of the Town Manager

A nother year has come and gone and each day I would try to start each day with the attitude that "an opportunity to learn would present itself".

I would like to begin with a heartfelt "thank you" to everyone. Your devotion to come together whether to "help out" or to "clock in" is amazing. Sebago is very fortunate to have people who care and support each other.

Department Heads, Capital Improvement Program Committee, Budget Committee and the Board of Selectmen met for another budget cycle. We have done our best to keep expenses low, but unfortunately there are items that are out of our control.

Last year Sebago successfully withdrew from M.S.A.D # 61 and formed its own school department. This endeavor was not only fiscally beneficial for the tax payers of Sebago, but ensured that our children will continue to have a quality education right here at home. By the time you read this, Sebago Elementary School will have completed its first year on its own. Thank you to everyone that made this possible.

In June 2018 voters approved a bond to build and pay for a 56KW solar array on the Sand/Salt Shed. This array will not only reduce our carbon footprint, but will provide Sebago the ability to offset a large portion of our electrical dependence on the electrical grid for many years to come. As part of the package, an electrical charging station is available for citizens at the Town Office. In addition, the town converted all town owned street lights to LEDs. It is my hope that this will result in savings for all taxpayers.

Public Works was busy reconstructing Hogfat Hill Rd. Mother Nature got a head start on winter so paving had to wait for this Spring. This spring, the crew will begin working on Hawkes Road and Peabody Pond Rd. Keep in mind that rebuilding a road takes time, please be patient with us.

Improvements were made to the Town Hall such as installing a 3-bay sink and stove hood, which were made possible through a Community Foundations Grant. I hope that in the near future we can get the gym painted, and perhaps have one of our local artists paint a mural or the Town seal on the back wall the stage This building is an important part of Sebago and needs to be maintained.

The annual "Sebago Days" event is held on the 3rd Thursday, Friday and Saturday in July. The awesome fireworks display is held on Saturday night.

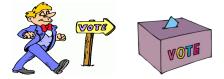

PUBLIC WORKS DEPARTMENT

To the Citizens of Sebago:

The Public Works Department partners with George Anderson & Sons, Inc. to provide the Town of Sebago Citizens with Highway Maintenance; independently providing both Vehicle and Building Maintenance. The Department has been operating with 2 full-time employees, and a Public Works Director since July of 2018. This is largely due to the retirement of Norman Storey, and the inability to hire qualified personnel to fill the vacant position. Robert Sanborn joined the team in October and has proven to be a valuable asset for both the Department and the Town of Sebago.

Highlights for 2018:

Hogfat Hill Road had 6/10ths of a mile reconstructed which included new culverts, and will be paved in the Spring of 2019 by F.R. Carroll.

Folly Road was graded and resurfaced with new surface gravel.

Goals for 2019:

Hawkes Road will have ³/₄ of a mile reconstructed with a new base, drainage, culverts and pavement.

Peabody Pond Road will be resurfaced, ditched and culverts replaced as needed to prevent continued erosion.

Site work for the new EMS Building addition.

The snow season during the reported period produced a generous amount of accumulation. The team worked tireless hours to ensure the safety and soundness for both Sebago Elementary School and the residents.

In closing, the Public Works Department and George Anderson's Crew will continue to work hard for you and your community.

SEBAGO EMS

To the Citizens of the Town of Sebago:

As the years pass by, it becomes more and more difficult to staff EMS with on-call providers as we did successfully for so many wonderful years. The daytime Per Diem program was created in the late 1990's to assist with this problem and has been very successful.

Currently, Sebago is able to staff the EMS building with 2 EMS providers during the day and, until the last several years, was able to cover calls at night with on-call from home EMS providers. Over the last several years this has become harder and harder to do as people move away, change jobs, or retire from EMS. Sebago EMS leadership has been mindful of these changes and is working hard to continue to provide high quality care to the citizens of Sebago.

In 2018, with your support, we started to provide overnight Per Diem coverage through the summer months. We were able to improve our call coverage by staffing the EMS station with 1 Per Diem provider between the hours of 6 pm and 6 am. The provider is often (but not always) a paramedic. At the end of the summer the overnight coverage ended, returning Sebago to its former staffing levels. This served to highlight the difficulties we have reliably covering our night time calls. Although we continue to be dedicated to delivering high quality service to the town, we have had to lean on our mutual aid agreements this past year more than we would like to. We hope to be able to increase our Per Diem coverage to 24 hours a day 7 days a week in the coming year so that we can provide you, the members of our community, with the high-quality EMS care you deserve.

We are looking forward to the upcoming expansion of the EMS building. The current building has served us well but is in need of expansion. We are excited to add appropriate sleeping quarters to the station for our summer overnight staff members. We are also excited to have a larger office space in which the EMS Deputy and Captain can work at the same time. Our current office allows for 1 administrator to work at a time. This space will also be a secure area which is needed in the medical community for privacy reasons.

As always, if you are in need of a CPR class please give us a call at 787-4120. The daytime EMS crew will take your information and be in touch with Deputy Schoolcraft who will assist you to schedule the class.

Thank you for all of your support over the last year, we could not provide the care we do without it.

SEBAGO COMMUNITY FIRE COMPANY REPORT

The Sebago Community Fire Company was formed in 1997 as a non-profit organization dedicated to raising money for the Sebago Fire Department. The Fire Company replaced the earlier Sebago Volunteer Fire Association, which had been formed in 1944 with similar goals. The Fire Company is a private organization, completely separate from the town, and can conduct fundraising and accept donations.

The officers for the Sebago Community Fire Company for 2018 are:

Firefighter Melissa Taylor, President Firefighter Christopher Harrington, Vice President

Captain Phil Strike, Treasurer

Over the years, the Fire Company has raised money, purchased equipment and generally provided support for the town's Fire Department to lessen the impact on taxpayers. In the 2018 year the Fire Company has held their annual Pancake Breakfast on Maine Maple Sunday in March, ran a wheel of chance game at Sebago Day's in July and has collected bottles and cans at their Station on Route 114.

The Fire Company also participated in the annual Mary's Fireman For A Cure Ski Race at Shawnee Peak in March, where towns from all over New England gather a team of five Firefighters and race down a solemn course to raise money for the Susan G. Komen Breast Cancer Foundation in hopes in finding a cure. Showing support and raising money for our town's Fire Department is something that the Fire Company takes great pride in, and the Company plans to carry this on for many years to come.

SEBAGO ELEMENTARY SCHOOL

We are officially half way through our first year as an independent school! We have accomplished so much in a very short time frame. We would like to thank the community for their overwhelming support as we continue to adjust to this new level of independence.

Projects we are working on:

- Forming a Pre-Kindergarten Committee to explore the possibility of having a Pre-K in Sebago
- Exploring different heating options for the school (i.e. Solar Panels, upgrading light fixtures, back-up generator, etc.)

Budget:

- April 16th Warrants will be ready to be signed by the Selectmen
- May 14th Town Meeting
- May 28th Budget Vote

What we have been up to:

- Hired 24 new staff at the beginning of the school year. Many of those positions were
 part-time and we are very excited with the caliber of folks we brought on board!
- Applied and received a grant in the amount of \$69,200 from the Volkswagen Environmental Mitigation Settlement to help purchase a brand new bus. The bus is ordered and will be here in May.
- Adopted a newer version of a math program that is preferred by teachers Everyday Math. We are really enjoying working with this program again and "playing" math games that really focus on learning math in a fun way.
- Restructured our reading program and focused on teaching literacy in a reader's workshop model. We are really working hard, especially at the first-grade level, to get everyone up to grade level. It is a big year for learning to read!
- Introduced IXL for math and literacy in all the classrooms. IXL is an online program which allows students to learn new concepts or practice topics they are struggling with. It is very engaging and is one way we can differentiate the learning opportunities for our students.
- We are now one to one with laptops for students in grades 2-5. We have 20 i-pads and five Kindles for our students in kindergarten and first-grade. The children of this generation are "Digital Natives". Part of our job as educators is to make them responsible consumers of their digital world. These laptops, i-pads, and Kindles make that even more possible!
- Thanks to the SPICE Committee, we have a brand new sign out front!
- In January and February, we had a series of extended school days on Wednesdays. The extra hour each week for five weeks allowed us to make-up the day in October when we didn't have power. In March/April, we stayed an extra hour for five Tuesdays and Thursdays in a row to make up another two snow days. We also made March 8th a student day. During those days, students participated in a variety of activities:
 - o Make-up PE classes (due to Monday early releases) on the Wednesdays
 - K, 2nd, and 3rd STEM lessons
 - o 1st grade is doing extra literacy lessons with Title I and Standards Interventionist
 - o 4th & 5th extra science and social studies lessons
 - Special Ed will do make-up services
- Professional Development for Staff:
 - Working on the Emergency Response Plan
 - Team Meetings



- Reviewing NWEA & IXL data
- Preparing for the MEAs
- Training for Everyday Math
- We had the GeoBee on Thursday, January 17th with Allen Crabtree as our moderator. In third place, we had Audrey Dubay. In second place, we had Ronan Davis. First place went to Brody Therriault. Brody took an online GeoBee assessment to try to qualify for the state level championship, which will be held in Farmington at the end of March.
- Superintendent Marc Gendron worked with the fifth-grade class on the Stock Market Game. Two of our teams came in first and second in the whole state! Mr. Gendron and the two teams will be attending a special awards banquet in May. They are already gearing up to see if we can do even better in the spring version of the Stock Market Game!

To the citizens of Sebago,

I have been your Animal Control Officer for just over a year and a half now and I have learned a lot and have enjoyed being your ACO. The position of ACO is a rewarding one the majority of the time, but I wouldn't change the job for anything. Should you ever have any questions comments or concerns please do not hesitate to contact me.

I would like to remind everyone, if you see a dead animal please do not touch them, if it is a domesticated animal (household pet) please leave them where you find them and call the ACO, I can hopefully locate the owner and bring closure to them. If it is a wild animal (not a household pet) you need to call a Maine State Game Warden. To reach the Warden Service please call Maine State Police Dispatch at 1-800-452-4664 (State Police Dispatch Augusta).

I would also like to remind everyone that you are required by State Law to register your dog. You can do this from mid-October of the current year until January 31st of coming year with no late fees attached. The cost is \$6.00 for Spayed/Neutered and \$11.00 for non-Spayed/Neutered. If you register your dog after January 31st, there is a \$25.00 late fee attached. If you do not register your dog you could be summonsed to Court which is a Civil Violation under State Law. The late fee does not apply if you are registering your dog for the first time.

GENERAL ASSISTANCE

I have been doing General Assistance since 2011 here in Sebago. Having to go by the State's rules and regulations is not always easy. The rules and regulations are updated every year and the Town must adopt 22 MRSA, § 4031 (5). Each year we are audited by the State.

General Assistance hours are on Tuesdays from 1:30 PM to 3:30 PM. For all clients that cannot make it, they may call the office for a time that works best for them.

Each client must bring proof of all income, expenses and a bank statement for the last 30 days for everyone in the household. If anyone is able to work and is currently without a job, they must show proof that they have been looking for work. This will need to be verified.

The budget this year was \$10,575.00. The budget for General Assistance has not been changed again this year. We spent \$2,499.96 for administration, \$60.00 for electricity, \$49.20 for heat, \$500.00 for rental, and \$825.00 for holiday assistance. General Assistance spent a total of \$3,934.16, leaving a balance of \$5,804.30. This was \$836.54 less than the previous year.

FUEL ASSISTANCE PROGRAM

This program is now going on seven years, thanks to many generous donations and fund raisings. Our thanks go out to Camp O-AT-KA for the Harvest Dinners they have put on for us, at no expense to us. This year we added the Blue Magic Band, which was enjoyed by all before dinner. Because of this we could help with heat for those who were not eligible for General Assistance but still in need.

SPAULDING MEMORIAL LIBRARY

At Spaulding Memorial Library, the Summer Reading Program started the fiscal year with four Wednesday mornings of stories and crafts for children.

Summer also kicked off the library's Push Back the Stacks program. These free family events usually include singers, musicians, authors, entertainers or natural history programs. Chewonki presented a Scales and Tails program on reptiles, including some live ones for all to have a chance to hold. Later Push Back the Stacks programs included author/hiker Allen Crabtree and Annegret Baier with her African drums.

Summertime was also the time for several library fundraising events. Sebago Days 2017 brought on the Book and Bake Sale. Also, in July, Pam and David Donohue again generously offered the use of their putting green for a putting contest that included a tasty meal and a silent auction, all helping to raise money for the library. During the Memorial Day weekend of 2018, the library held its Book, Bake, and Plant Sale, a popular event for getting gardens ready and stocking up on summer reading.

December 2017's Cookie Walk was another successful and delicious fundraiser for us. Many volunteer bakers contributed to its success, as well as having baked for our summer fundraisers.

Community members were invited to Take Your Child to the Library Day in February which also offered free vision testing of children by the Sebago Lions. Lawyer in the Library Day (free general legal advice) and Meet the Candidates for selectmen positions were also sponsored by the library. The Sebago Historical Society held its Veterans Day program about Sebago veterans at the library.

Lakes Environmental Association and the library started a series of family nature walks. Unfortunately, the response was limited. Let the library know if your family would be interested in such a program in the future. Our monthly Read to a Dog program invites anyone to come in and read and visit with Addie, a therapy dog. (Children must be accompanied by an adult.)

During the school year, elementary school classes visit the library each month for a story, a library lesson, and a chance to browse the many children's books and take out some to read at home.



The library continues to be a very active participant in the Maine State Library's Interlibrary Loan Van Delivery. Thanks to a grant to the State of Maine, we are one of the libraries who can send to and receive books from other member libraries at no cost to us. About 400 books a year are handled this way. So, if you know of a book you would like to read and we don't

have it, see if we can borrow it from another library

From September through May, the library sponsors a monthly Book Discussion Group, open to any adult who likes a lively and fun conversation about each month's selection. (There is no need to buy each month's book; we get copies interlibrary.)

About 355 people attended meetings at the library in the last year. Organizations meeting here have included Sebago Days, SES Transition Team, SPICE (Sebago Partners in Community Education), and Potter Trustees. Other groups are welcome to contact us as a possible meeting site.

In terms of the physical property of the library, a new bulkhead entry was installed this

past fiscal year, as well as a new water pump and new entrance columns.

Besides books, audio books, magazines, and films to take out, the library offers free WIFI, computers to use at the library, lowcost photocopying and faxing and a beautiful place to come by and enjoy. About 4300 patrons, visitors, and friends came to the library in the past year, we hope more will this next year.

The trust was created by a gift of \$33,528 by Dr. Joseph Fitch Potter in 1894. It is invested in two Bangor Savings Bank Cds. which on March 11,2019 will be valued at \$38,386.96. One is a 12 Month for CD \$1,194.64 the other a 24 Month CD for \$37,192.32.

Potter Trust mission: "Board shall have, receive, hold and manage the money received under the testament and will of Dr. Joseph F. Potter for certain educational, charitable and religious objects and purposes."

There were no distributions in 2018.

At a meeting on February 06, 2019, the trustees voted a stipend of \$250 for the Church of the Nazarene, a gift of \$500 to Sebago Elementary School and \$250 to "Holly Jolly Helpers".

The CDs' will be restructured to take advantage of higher interest rates into a 27 month CD for \$34,000 with remaining balance into a 12 month CD. The funds will be withdrawn and the checks for this year's distribution written when a mature CDs' rolls over on March 11.

SEBAGO HISTORICAL SOCIETY

The Sebago Historical Society meets on the 3rd Wednesday of each month at 7 PM. During the warmer months, May through September meetings are held at the Historical Society museum (the former Free Will Baptist Church built in 1844) located at 347 Convene Rd, and during the colder months, Oct through April they are being held at a member's house. As always, all meetings are open to the public. We welcome visitors to view our displays and research family history during our summertime open hours, which are on the 3rd Wednesday of each month from 2 PM to 7 PM, before our monthly meeting.

Many services are provided to the citizens of Sebago and others interested in our town history. We make visits to the elementary school children, bring displays to them, or have them visit our building to view our exhibits and participate in hands on history lessons. Notebooks of family histories are available, with genealogical lines of ancestors, which were donated by family members or completed from our own research.

The theme for the 2019 Sebago Historical Society calendar is again Neighborhoods of Sebago, this year featuring Kimball Corner Rd in North Sebago. The calendars are a source of historical information about our town, its citizens and life in an earlier time. The calendar is our major source of income, and provides area businesses with the opportunity to advertise their business or service.

We had a number of public speakers in 2018, including a Public Presentation by Caroline Grimm on her newest book in the Voices of Pondicherry series, The Old Squire.

Antiques appraiser and collector Glenn Grant came for another Antiques Roadshow - Sebago Style. This is always a popular event with folks from Sebago and neighboring towns bringing items to be appraised.

Our Historic House tour was at the former Jackson Farm at the foot of Poor's Hill. It was very well attended, as they all are.

The Veteran's Day Program at the Spaulding Memorial Library follows the Lions Club's program at Veteran's Park. We're continuing to solicit photos of Sebago's veterans, not only those who enlisted from Sebago, but also anyone who has lived in Sebago and is a veteran. Please contact a member of the historical society or inquire at the library if you have a photo to share.

We held another Open House in September, inviting the public to visit our display shed that houses larger items. Demonstrations of ice cream making with a hand cranked machine, printing with an antique letter press machine and a 1800's sock knitting machine demonstration were the main features.

As always we had a booth at Sebago Days with our calendars and historical books, postcards and maps available for sale.
