Paul suggested that financing could be done in three different ways: Loon Echo Land Trust, Inc. could generously take on the project; they could apply for a grant; or the town could raise monies. Paul stated that he is not committed to any of these, but would like to actively pursue the matter.

Tina Vanasse asked if the land was owned by the town. Paul White confirmed that the land where the access point would be is owned by Loon Echo Land Trust, Inc.

Paul White motioned to approve sending a letter to Loon Echo Land Trust, Inc. It was seconded by Joe McMahon. Motion carried with all in favor.

Paul White suggested that a copy of the letter be sent to the Board of Selectmen as well. Also, if the Conservation Committee starts again maybe they could look into grant monies for the project.
